## Application for Rodeo Sanction Form Rules of Sanction

Committees desiring a National Senior Pro Rodeo sanction of their rodeos must make application to the National Senior Pro Rodeo office in time to be published in at least one publication of the official association newspaper. Time of at least 45 days should be allowed for publication and mailing before the date of the first performance. **Minimum Added Money:** at least one rodeo at one location must have added money in the amount of \$1,000 which breaks down to \$250 per riding event and steer wrestling. **Suggested added money (NOT required)** per rodeo is as follows: \$300 per riding event and steer wrestling; a minimum of \$150 per age group for team roping and \$100 per age group for ribbon roping; \$50 per age group for tie down roping and ladies barrel race; and \$50 for Men's and Ladies Breakaway (for a total of \$2,100 per rodeo). Minimum entry fee is \$40 per person. All rodeos must have the standard events of bareback, saddle bronc, bull riding, steer wrestling, tie down roping, team roping, ladies barrel race, ribbon roping and men's and ladies breakaway. However, a committee may choose to have a "timed event only" rodeo, excluding the rough stock events. A \$100 sanction fee for each rodeo location, per weekend, must accompany this contract along with a \$100 refundable bond for each location. Please fill in all of the information. If using one form for back-to-back rodeos, be sure dates and times are clearly specified. Copies of this application can be copied or downloaded from our website. If you have any questions, please contact the National Office at 928-684-9566. Effective January 2009, the rodeo committee will be responsible for Central Entry costs if your rodeo is canceled.
